**** As of September 1, 2006, the Deputy Sheriff Training fund can be added into the Sheriff's check****
 *** each Garnishee adds \$20.00 to the training fund due to the two additional services required while doing
 Garnishments. (Example serving a writ and interrogatories to PNC Bank in Erie as a Garnishee, \$60.00 Writ,
 \$50.00 Interrogatories, \$8.00 Mileage = \$118.00 to the Sheriff and \$20.00 for Garnishee, and \$10.00 for the
 Defendant = \$30.00 to the Deputy Training fund.)

Service of Papers outside of Pennsylvania: Add \$10.00 to each Defendant for Notarization and Certification and a self-addressed stamped envelope to mail the return back. Deputy Training Fund Fees must be added.
